# Privacy Notice for the Unitholder's Meeting North Bangkok Power Plant Block 1 Infrastructure Fund Electricity Generating Authority of Thailand (EGATIF)

Krung Thai Asset Management Public Company Limited (the "Management Company") realized the importance of personal data of protection of unitholders and/or proxy holders. This privacy notice, pursuant to Personal Data Protection Act B.E. 2562 (2019), shall be applied for the collection, use, disclose, and processing of personal data to verify the identity of unitholders and/or proxy holders directly and/or indirectly. The details are as the follows:

#### 1. Personal Data to be Collected

The Management Company will receive and collect personal data directly from unitholders and/or proxy holders and from Thailand Securities Depository Company Limited, the Management Company's unit registrar. Personal data consists of followings:

- 1.1 <u>General Personal Data</u> such as name, surname, identification number, date of birth, gender, nationality, unitholder identification number, number of unit, image, video recording as well as health information and travel history for public health objectives in preventing the Coronavirus Disease 2019 (COVID-19).
  - 1.2 <u>Contact Information</u> such as address, telephone number, and email

### 2. Purpose of Collection, Use and Disclosure of Personal Data

The Management Company collects, uses, and discloses personal data for the following purposes:

- 2.1 To call, arrange and conduct the Annual General Meeting of Unitholders of the Fund pursuant to the Fund Scheme as well as applicable laws, notifications and criteria for meeting arrangement as stipulated by the government and preparation of minutes.
- 2.2 To be used for screening attendees who are at risk for COVID-19 to achieve public health objectives for the prevention of dangerous communicable diseases and to comply with the measures and guidelines for meeting arrangement.

#### 3. Disclosure of personal data to third parties

The Management Company may disclose personal data to persons or agencies related to items 2.1 and 2.2 including but not limited to meeting arrangement consultants or government agencies related to public health and communicable disease prevention.

## 4. Rights of Data Subjects

The data subjects have the rights, under to the Personal Data Protection Act B.E. 2562 (2019), to withdraw consent, to request access to and obtain a copy of their personal data, to request for correction, deletion or destruction of their personal data, to suspend the use of personal data, to request for personal data transfer according to the methods prescribed by the law as well as to lodge a complaint and to object the collection, use or disclosure of their personal data.

#### 5. Personal Data Retention Period

The Management Company will retain personal data under item 1 within the period the Management Company can collect or required by relevant laws to collect and/or as long as necessary to achieve the purpose under item 2.
